
Analog Adapter (PS-2158)



Introduction

The PS-2158 Analog Adapter allows you to use an analog ScienceWorkshop sensor with a PASPORT interface. Multiple Analog Adapters can be used simultaneously to support multiple ScienceWorkshop sensors.



NOTE: When using an analog ScienceWorkshop sensor with the Analog Adapter, the sample rate for the analog sensor is capped at 1000 Hz.

Equipment and software setup

PASCO Capstone or SPARKvue is required to use the Analog Adapter. Visit www.pasco.com/downloads to download the latest version of each program.



▲ PASCO capstone™

- Connect an analog ScienceWorkshop sensor to the cable of the Analog Adapter.
- 2. Connect the Analog Adapter to a PASPORT interface. Turn on the interface if applicable.
- Start PASCO Capstone, then select Hardware Setup from the Tools palette.
- Connect the PASPORT interface to the computer via Bluetooth or USB. Upon connecting to the interface, the program should automatically detect and recognize the Analog Adapter.
- From the Hardware Setup tool, click inside the yellow circle on the symbol representing the Analog Adapter, then select the analog sensor connected to the Analog Adapter from the dropdown list.



SPARKvue®

- Connect an analog ScienceWorkshop sensor to the cable of the Analog Adapter.
- Connect the Analog Adapter to a PASPORT interface. Turn on the interface if applicable.
- Start SPARKvue, then select Sensor Data from the main menu.
- Connect the PASPORT interface to the computer via Bluetooth or USB. Upon connecting to the interface, the program should automatically detect and recognize the Analog Adapter.
- Under the Select Measurements for Templates menu, locate the section for the Analog Adapter, then click the Configure Sensor icon to open the Assign Analog Adapter menu.
- From the Assign Analog Adapter menu, select the name of the analog sensor connected to the Analog Adapter.
- Optional: If desired, adjust the gain of the sensor by clicking the Low (1x) box and selecting the desired value from the dropdown list.



NOTE: The default gain of 1x works well for most applications.

8. Click OK to close the Assign Analog Adapter menu.
